Re: Remove the web links of *Meet the Flockers*

Dear Mr. Walker,

I would like to follow up with you as to the status of removing “Meet the Flockers” from Google or YouTube searches. I really appreciate that one of “Meet the Flockers” MV links was removed from YouTube recently.¹ However, multiple other links of this song still exist on Google or YouTube search.²

This letter serves to demand the immediate removal of any and all links to the rap artist YG’s “Meet the Flockers” lyrics and video within Google and YouTube’s access and control. Based on our preliminary research, such bigoted and hateful criminal advocacy is not protected by our Constitution. (See Watts v. United States, 394 U.S. 705 (1969); Virginia v. Black, 538 U.S. 343 (2003); Wisconsin v. Mitchell, 508 U.S. 476 (1993).

While artistic expression has traditionally enjoyed broad First Amendment protection, the serious harm caused by YG’s lyrics and video, from promoting crime and advocating injury to Chinese Americans as a particular group of people, has moved “Meet the Flockers” far beyond the

threshold of speech protected by the First Amendment. In fact, YG's video, with its crime-instigating lyrics, amounts to no other but hate speech.

Although the video of YG's "Meet the Flockers" has been removed by YouTube following complaints by Chinese and Asian groups, many remaining links and caches exist where it can still be accessed and viewed. To prevent further violence, we respectfully demand that Google and YouTube expend their best efforts to take down any and all remaining links that you are able to access and control.

Violence to one is violence to all³. Since "Meet the Flockers" was posted on the internet, both Asian American neighborhoods and some major cities in the U.S. have experienced a spike of crimes.⁴

Enclosed, please find a copy of the letter addressed to the U.S. Department of Justice and a copy of press release from Committee of 100 for your reference.
